The WiT Board Readiness™ program is offered in a small group format capped at 20 participants. The application process is competitive and based on an assessment of the applicant's skills and experience along with their suitability to take on Board roles in the future. WiT reserves the right to reduce the cap in the event that candidates of sufficient quality cannot be placed. The WiT Board's decision on candidate selection will be final.

Criteria for the program are:

- Looking to join a board in the next 2-5 years
- 5+ years' experience in leadership of a business or a component of a business relevant to your industry background (teams, etc)
- Demonstrated readiness to complete the program (based on assessment of below selection criteria)

These criteria will be assessed based on:

- Your responses to the Selection Criteria below
- Referee support
- Your experience as demonstrated in CV

Reference provided - one professional referee to be nominated that would support your application.

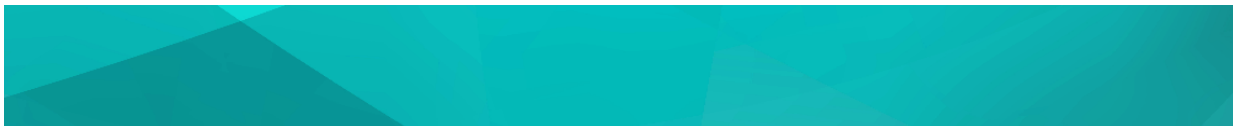
